## Director, Wastewater Treatment & Residuals Management, Operations & Maintenance

The regional district is governed by a Board of Directors of elected officials from each local authority. Metro Vancouver employees serve and help share one of Canada's most desirable regions.

Metro Vancouver's wastewater treatment division is comprised of five regional wastewater treatment plants which process over 1 billion litres of wastewater generated every day by residents, businesses and industries to protect public health and the environment. The Director, Wastewater Treatment & Residuals Management, Operations & Maintenance, will lead the Wastewater Treatment and Residuals Management function for the department which processes over 450 billion litres of wastewater and 95,000 tons of residuals annually. This role is responsible for providing strategic direction and managing the treatment and residuals management systems and performs a key role in the delivery of essential utility services to region. They will work closely with the Deputy General Manager, LWS to develop and implement the department's short and long-term strategies and plans. The Director will oversee an annual divisional budget of approximately \$110M carried out by 217 talented and dedicated staff.

The ideal candidate brings progressive experience as a strong leader with both vision and a steady hand, and has excellent coaching, development and communication skills. In a progressive workplace, you will keep motivation high and drive innovation wherever it promises to improve efficiencies or processes. You have a strategic mindset and are comfortable leading change across a complex, multi-site organization, building consistency across plants to optimize the performance of the function. Knowledge of wastewater treatment systems and a P.Eng is an asset.
