Robert briefly highlighted some items from the rolling actions items:

### **Item 4.0: Executive Director Reports**

### Item 4.1: CWWA Activity Report & Committee Updates

Robert highlighted the following in his activity report:

- Staff has successfully transitioned to working from home on a daily basis.
- Membership target for 2020 has been reached
- New website was created in house due to budget restrictions
- New Member's only part of the website to be budgeted in 2021
- New Covid-19 updates on website
- Advocacy has been well received
- WOO webinars were very successful
- NWWC has been brought online through our new webinars and will be held from December 2020 February 2021.

Highlighted committee work. It was noted that the lack of travel seems to have created more focus on committees and advocacy.

# Item 4.2: 2019 Activity Report and 2020 Goals/Projects & Events

Robert presented his 2020 Year End Summary and 2021 Work Plan with a focus on member retention, advocacy and moving our events online.

#### Item 4.3: Membership Report

Robert reviewed the membership reports indicating new members and lost members in 2020 with a 5-year revenue comparison. He noted we are very close to reaching our 2020 target. He spoke of a retention program to roll out in January, as there is worry that next year we will lose members due to Covid-19.

#### **Item 5.0: Financial Reports**

#### Item 5.1: Year to date financial report to SEP 30<sup>th</sup>, 2020 Revised 2021 Forecast

Greg Archibald introduced Clare Pama of Otus Group who presented the financial statements to the end of September. Covid-19 has not affected our revenues as we deeply as first projected. Memberships were collected prior to the pandemic. We had projected a 50k loss due to no conferences this year, but that was countered by savings on the following expenses such as Robert's travel, office expenses, and conference expenses. CWWA also made a profit of \$5,000 on the virtual Window on Ottawa of 5K, which is greater than the in-person conference we have held in the past.

We have also received significant subsidy payments from the federal government and it appears we could end the year with a projected surplus of \$35,000.

# Item 5.2: Preview of 2021 Budget

Robert noted that a more formal 2021 budget will be presented in the first part of the new year as Covid-19 has created so many uncertainties around membership renewal and event revenues.

Robert did present a 2021 budget scenario document to show best and worst case scenarios for our memberships and events suggesting an expected loss between \$70-\$100,000.

Moved by Greg Archibald and seconded by Ryan Johnson that CWWA membership rates be increased by 2% for the year 2021.
