The Operational Performance Leader – Stormwater is a new position in the Water Utility that will help further build and develop our stormwater operations to support the City's stormwater strategy. You will be building a team of management exempt Engineers and Planners as well as unionized technical staff to work with the management team and operations to deliver front line stormwater service to our customers. The Operational Performance Leader - Stormwater will provide strategic oversight of their section, influence the strategic planning and forecasting of their Division and the Field Operations work and will be responsible for ensuring a customer-focused approach to service within their area. Primary duties include:

- Actively participating in, and engaging with, the Stormwater Service Team, helping to shape the Utility's enhanced focus on stormwater management and service delivery
- Working with Planning and Operations to develop and implement strategies to achieve the goals
 of the Stormwater Strategy
- Provide short and long term strategic business development and action planning on behalf of the section and will ensure sound relations with other internal Divisions, Business Units, Intergovernmental bodies (for example: Federal and Provincial), and community stakeholder groups.
- Develop, implement, and support business process changes and operational strategic thinking that encourage business optimization and service improvements. Understand and achieve all applicable regulatory requirements is imperative to this role.
- Work closely with the Drinking Water Distribution, Wastewater Collection and Field Operations Leadership teams to ensure that business optimization supports the achievement of the division's asset management, maintenance planning, system monitoring and operational objectives. Improvement initiatives will be identified through a variety of means: performance measurements, trending, benchmarking, analysis of existing operational practices and research of best practices.
- Responsible for financial planning, management and reporting on the financial performance of the Section.
- Coach, develop and supervise a skilled group of professionals while creating line of sight for employees to the Stormwater line of service Business Plan. Responsible for all the resources of the Section, including hiring, staff development and performance management.

Qualifications

- A degree in Business, Engineering or Applied Sciences combined with at least 8 years of related experience involving the supervision of complex operational work.
- Use of a personal vehicle for occasional business purposes.
- A valid class 5 driver's licence and ability to obtain a City of Calgary operator's permit.
- A professional designation such as P.Eng, Chartered accountant (CA), Certified Management Accountant (CMA) or Project Management Professional (PMP) is considered an asset.
- Equivalent combinations of experience and education may be considered.
