CONTEXT



- Freshwater challenges are on the rise in Canada (scarcity, water quality, availability, extreme events, etc.)
- Water challenges are linked to biodiversity, climate, economic and social issues.
- Water is central to First Nation, Métis and Inuit cultural, spiritual and social life.
- Water realities vary across Canada's regions
- There is a recognized need for national coordination on water management
- Over 20 federal departments are working on freshwater activities
- Canadians and Parliamentarians are increasingly paying attention to water issues

CURRENT STATUS




Feb 2023: Budget 2023 calls for funding for CWA programming and commits to introducing legislation to establish the CWA as a standalone entity.

June 20 2024:


The legislation received royal assent.

Oct 16, 2024:

The Standalone Agency was launched in WPG.



Legislation (Canada Water Agency Act) was introduced to create the standalone CWA.



The coming-into-force Orders in Council are signed.

- The agency headquarters are in Winnipeg, a historical gathering place for Indigenous peoples and home to Lake Winnipeg.
- The CWA also has regional offices throughout Canada.

WHAT DOES A STAND-ALONE AGENCY MEAN?

- 1. Direct reporting relationship with the Minister of the Environment and Climate Change
- 2. Greater visibility on freshwater challenges and opportunities.
- 3. CWA's work will be complementary with other water functions from ECCC (i.e. freshwater science and monitoring)
- 4. Responsible to provide Minister with a whole-of-government perspective
- 5. Responsive organization that is committed to delivering results



OUR MANDATE





1. Provide federal freshwater policy leadership and a wholeof-government approach to freshwater management



2. Collaborate with provincial, territorial and Indigenous partners



3. Facilitate access to federal freshwater information



4. Collaborate with stakeholders and provide funding and support for partner-led projects



5. Leverage freshwater data and science for better outcomes



6. Enhance cooperation on transboundary watersheds

The Freshwater Action Plan

The CWA is investing in partner-led projects to restore and protect water quality and ecosystem health in waterbodies of national significance.

Canada Water Act Review

A two-step process engaging Canadians on reviewing the Act to better reflect modern freshwater realities.

STRENGTHENING FEDERAL COORDINATION









A Federal Freshwater Committee

A permanent committee involving all 25+ depts/agencies with freshwater activities.

A Federal Freshwater Hub

An innovative hub that colocates employees from depts/agencies with freshwater activities for 1–2-year assignments.

Water One Window (WOW)

A user-friendly online portal through which Canadians can easily access freshwater data and information.

National Freshwater Data Strategy

Developing data standards to enhance data accessibility and interoperability.

KEY MESSAGES




- Freshwater challenges are becoming an increasing issue across Canada, we have heard from Canadians, and we are taking action.
